TYPES OF MEMBERSHIP:

1. Regular Membership shall be open to the following, provided they are duly registered with the government:

- a. Individual churches with at least 25 adults (voting) members and a written constitution. (In special cases, registration with the government may be waived at the discretion of the PCEC Board of Directors).
- b. Fellowships (or associations) or independent churches.
- c. Denominations (at least 100 church members).

2. Associate Membership shall be open to the following, provided they are duly registered with the government:

- a. Missionary societies.
- b. Bible schools, seminaries and other evangelical institutions of learning.
- c. Church-related service agencies or establishments.

3. Special Membership may be granted to any group which falls under one of the categories above but whose constitution or practices limit their cooperation with PCEC only to certain areas of its objectives. These limitations must be specified in their application and entered in the minutes of the Board of Directors meeting or the National Assembly. This will limit the responsibility of PCEC for these groups, as specified.

Every member shall pay the Annual Membership Fee as determined by the PCEC National Assembly.
